# I. Our Approach to Green Procurement Standards

# 1. Purpose

The purpose of these standards is to contribute to the conservation of the global environment and the creation of a recycling-oriented society by procuring products with low environmental impact from suppliers who are actively engaged in environmental conservation activities and providing them to our customers.

## 2. Scope of application

- (1) These standards apply to the following:
  - Environmental activities of suppliers
  - Products supplied to the Hoei Group
- (2) "Products" means purchased parts, products, equipment, etc., subcontracted goods received through manufacturing consignment, processing consignment, repair consignment, etc., accessories, packaging, and all other items delivered with products.

#### 3. Procurement standards

The following three items, together with quality, price, delivery time, etc., will be used to make comprehensive decisions on the selection of suppliers.

(1) Environmental conservation initiatives

Priority will be given to suppliers who are actively engaged in environmental conservation activities.

(2) Management of chemical substances contained in products

Since chemical substance management throughout the supply chain is required to comply with regulations on the chemical substances contained in products, priority will be given to suppliers who implement management of the chemical substances contained in their products.

(3) Status of chemical substances contained in delivered products

For products delivered to Hoei Denki, in addition to not containing the following (i) Prohibited substances and (ii) Conditionally prohibited substances, we will give priority to suppliers who are able to report on the content status of (iii) Reportable substances.

- (i) Prohibited substances: Must not be contained in products.
- (ii) Conditionally prohibited substances: Must not be contained in products except for exempted uses as defined by law.
- (iii) Reportable substances: Substances whose content in products is to be reported.

Details of target substances and exemptions are in accordance with domestic and foreign laws and regulations and designations made by Hoei Denki.

- Examples of laws and regulations in Japan:

The Act on the Regulation of Manufacture and Evaluation of Chemical Substances, Industrial Safety and Health Act, Act on the Protection of the Ozone Layer Through the Control of Specified Substances and Other Measures, Act on the Promotion of Effective Utilization of Resources, etc.

- Examples of laws and regulations outside Japan:

The EU RoHS Directive, EU REACH Regulation, EU POPs Regulation, EU Packaging Directive, EU ODS Regulation, German Chemicals Prohibition Ordinance, etc.

EU RoHS Directive:

Restriction of the use of hazardous substances in electrical and electronic equipment

EU REACH Regulation:

Registration, evaluation, authorization, and restriction of chemical substances

EU POPs Regulation:

Elimination and restriction of the production and use of Persistent Organic Pollutants (POPs)

EU Packaging Directive:

Regulation of the use of hazardous substances in packaging materials

EU ODS Regulation:

Regulation of the use of Ozone Depleting Substances (ODS)
